# **OFFICE REPORT**

It is submitted that as per the Government of India, Ministry of Finance, Department of Expenditure, Finance Commission Division letter no. F.15(3)FC-XV/FCD/2020-25, dated 25-02-2021, the Government of India has released Rs. 69,50,00,000/- (Rupees Sixty Nine Crore Fifty lakh only) as Untied Grant including Cantonment Boards. In this connection as per Secretary Finance Department, Uttarakhand letter No.284/02 (वि.आ. निदे)/xxvii(1)/2021 dated 01<sup>st</sup> March 2021, Rs 36,73,000/- (Thirty Six lakh seventy three thousand only) has been allotted to Cantonment Board, Ranikhet which has been realized by this office.

Further it is pertinent to mention here that as per the terms and condition mentioned in letter from Secretary Finance Department, Uttarakhand letter No.284/02 (वि.आ.निदे)/xxvii(1)/2021 dated 01<sup>st</sup> March 2021.the allotted fund i.e. Rs. 36,73,000/- can be utilized as "स्थानीय निकायों द्वारा वेतन या अन्य स्थापना व्यय को छोड़कर, स्थान-विषिष्ट आवष्यकताओं (Location-specific felt needs), के लिये किया जा सकता है।"

It is also submitted that the 4<sup>th</sup> Installment of Grant allotted by State Govt. under 15<sup>th</sup> CFC has also been received in Cantt Fund Account i.e. Rs. 36,73,000/- on dated 19<sup>th</sup> March, 2021 but the letter of State Govt. regarding allotment of said grant is not received in this office till date.

In this connection, further various development works need to be executed through above fund. The list of the development works proposed to be executed through the above fund is placed on the table.

Hence the matter is placed before the Board for information and appropriate decision.

# **RESOLUTION**

03. Considered, noted and approved as per agenda. The CEO informed the board that the 4<sup>th</sup> installment of 15<sup>th</sup> CFC fund has also been received vide Secretary Finance Department, Uttarakhand letter No.256/03 (वि.आ. निदे)/xxvii(1)/2021 dated 18<sup>th</sup> March 2021 for utilization as 50% in water conservation and 50% in solid waste management. The board approved the estimates & works and resolved that proposed works should be executed through the fund received from 15<sup>th</sup> CFC. The fund should be utilized as per terms and conditions mentioned in letter of Finance Department, Uttarakhand.

The utilization certificate for 2<sup>nd</sup> installment could not be submitted in time, due to the various reasons mentioned in report of Engineering Section 18-03-2021 and report of Store Section dated 18-03-2021.

The board resolved that the utilization certificate of  $2^{nd}$  and  $3^{rd}$  installment should be submitted till  $31^{st}$  March, 2021 and  $31^{st}$  April, 2021 respectively.

Further board resolved that the utilization certificate of 4<sup>th</sup> installment be submitted upto 31<sup>st</sup> May, 2021 as directed by State Govt. Keeping in view the short duration of time work should be executed through existing contractors for specific works after finalization of works by PCB and simultaneously process for E tender be started for next year.

To consider the matter regarding grant of 3<sup>rd</sup> MACP to Smt. Rama Negi, Office Supdt., Cantt Board, Ranikhet.

### **OFFICE REPORT.**

It is submitted that Smt. Rama Negi has requested to this office for grant of 3<sup>rd</sup> MACP/Financial Benefits as per Uttarakhand G.O. No 11/XXVII (7)30(14)/2017, dated 17-02-2017 from the Pay Scale 9300-34800 GP 4200 to Pay Scale 9300-34800 GP 4600.

In this connection it also submitted that as per example (vi) of Uttarakhand G.O. Rama Negi was initially appointed on 01-09-1995 in the post of Steno Typist in Pay Scale 1200-30-1560-EB-40-2040 4<sup>th</sup> CPC (BP 4000-6000 5<sup>th</sup> CPC) (BP 5200-20200 GP 2400 6<sup>TH</sup> CPC). Smt. Rama Negi granted 1<sup>st</sup> ACP after completion of 10 years satisfactory service BP 5200-20200 GP 2800 w.e.f. 01-09-2008. Thereafter Smt. Rama Negi promoted to the post of Accountant in the pay Scale BP 9300-34800 GP 4200 w.e.f. 01-10-2009. Afterthat Smt. Rama Negi promoted to the post of Office Supdt. in the same pay scale BP 9300-34800 GP 4200 on 01-02-2012. It is clear that no financial benefit was given to Smt. Rama Negi on the promotion to the post of Office Supdt.

At present the pay scale/Grade Pay of Accountant and Office Supdt. is same i.e. BP 9300-34800 GP 4200, due to which no financial benefits was given to Smt. Rama Negi on the promotion to the post of Office Supdt.

Thereafter he was granted Selection Grade scale (p;u osrueku½ on completion of 14 years of satisfactory service on the post of Toll Collector.

In accordance with Uttarakhand G.O. No 589/xxvii (7)40(ix)/2011, dated 01-07-2013 a proposal was forwarded to higher authorities by this office vide letter No 121/ACP/SC(T)/2019,dated 14 January 2019 regarding grant of 2<sup>nd</sup> and 3<sup>rd</sup> ACP to Shri Bhupal Singh Nagarkoti, Senior Clerk on completion of 26 years of satisfactory on the post of Toll Collector but PDDE vide their letter No 34238/RKT/S.Clerk/19(C-815)/3 dated 22 July 2019 has directed that the individual is entitled for only three assured financial upgradations (ACP/Promotion) from the date of appointment not from the promotion date of Toll Collector and returned the proposal un-sanctioned in original.

In this regard it is pertinent to mention here that this office conducted a survey for identification of vendors, wherein total 68 vendors are identified within Cantonment limits in Ranikhet. As per point No. 12 of the Uttarakhand Gazette No. 825/IV(2)-\$\forall 0\rightarrow 2016-246(\forall 0)-04-TC1, dated 25<sup>th</sup> May, 2016 vendors committee have to be constitute in this regard.

Hence the matter is placed before the board for their consideration and necessary direction.

The Board may consider the matter accordingly.

# 10. IMPLEMENTATION OF E-CHHAWANI PROJECT.

#### **OFFICE REPORT**

It is submitted that the E-Chawani Portal phase-I has been launched by Min. of Defence, Govt. of India for all Cantonment board in India. Under E-Chhwani Portal the public grievance redressal system (PGR), M-Collect (Online collection of non taxes), online issuance of trade license and online application for renewal/extension of leases have been introduced.

In this connection the DGDE, New Delhi vide letter No. 76/67/e-Chhawani/C/DE/2020, dated 14<sup>th</sup> Jan 2021 and dated 22<sup>nd</sup> Jan, 2021 has directed to Cantonment Board :-

- 1. To consider to provide proposal for some incentives for encouraging online payments.
- 2. To impose administrative charges on offline payments (Cash, Cheque, Demand Draft).
- 3. Accept payments for EMD, security deposit, school fee, lease rent only online mode.
- 4. Booking services (rangoli hall, multipurpose hall, guest house, water tanker, demarcation fee and ground rent) only online mode.
- 5. All online transaction charges on master/visa/rupay/credit/debit/net banking/UPI/Wallet will be bear by the Cantonment Board.

As per report of Revenue Supdt dated 21-01-2021, the Cantonment Board, Ranikhet is facing financial crisis, hence, the board will not be able to give any incentive for online payment.

Hence the matter is placed before the board for noting.

# **RESOLUTION**

10. Considered and board resolved that the financial condition of board is not good to give any incentive for online payment. But, appreciation certificate/message can be given to individual. Further board resolved that other payment facility will also be provided to public and after some time online payment may be made compulsory.

Rs.500/- per day will be charged for extra additional room

Refundable Security money will be
Rs. 3,000/- for Booking (under terms & Conditions)

Rs. 20,000/- per day including one room and one bathroom
Rs.500/- per day will be charged for extra additional room

For Cantt staff/members and their dependants:

Rs. 15,000/ per day including one room and one bathroom
Rs.500/- per day will be charged for extra additional room

Refundable Security money will be Rs. 5,000/- for Booking (Under terms & conditions)

It is pertinent to mention here that many times the general public and political parties/private parties have requested to allocate the multipurpose hall for hourly basis, but due to non-fixation of hourly rates, it is not possible to allocate the hall. It is proposed to provide it @ Rs. 3000 only for meeting/seminar on hourly basis upto 6 hours, the other rates are applicable as per the Board resolution No. 35, dated 30<sup>th</sup> March, 2016.

Hence the matter is placed before the board for their consideration and necessary direction.

The Board may consider the matter accordingly.

### **OFFICE REPORT**

It is submitted that the matter regarding auction/renewal of occupancy rights of Cantonment Boards shops/stalls/kiosks situated in Class "C" and "B-4" land was placed before the finance committee meeting held on 24<sup>th</sup> July, 2020. The same was confirmed by the Cantt Board vide its resolution No. 11, dated 04<sup>th</sup> August, 2020.

After the detailed discussion the Board vide its resolution No. 11, dated 04<sup>th</sup> August, 2020 resolved that "board resolved by majority that the shops in question be allotted for 364 days w.e.f. 1<sup>st</sup> April 2020 to 30<sup>th</sup> March, 2021 on payment of Stallage/ Damages fee/licence fee by enhancing the fee mentioned as under:-

(i) Upto 5,000/- - by increasing 5% (ii) 5,000/- to 10,000/- - by increasing 4% (iii) Above 10,000/- - by increasing 3%

Provided further that the enjoyment of any such aforesaid right by any person for any length of time shall never be deemed to create or confer any tenancy right in such stall, shop, standing, shed, pen, public market or public slaughter-house.

Board cleared that presently the percentage increase in the fee has been revised @ 50% of the proposed rates till Dec. 2020 due to pandemic situation of COVID-19. Further the board resolved that if the situation of covid-19 improves and gets in control the percentage increase in licence fee will be reviewed".

In this regard it is pertinent to mention here that presently the situation of COVID-19 is slightly improved than before. It is also stated that the current financial year yet to be closed, and if any amendment is made in the earlier decision of the board, the recovery of taxes may be affected, therefore the percentage of increase in licence fee may be extended till March, 2021 i.e. end of financial year 2020-21.

The matter is being placed before the Board for consideration and necessary direction.

Relevant file with the application of applicants is placed before the Board.

### **RESOLUTION**

In this regard the Board resolved that "Considered. The CEO read out the Agenda and informed to the Board that the contract for collection of Parking fee has been executed since July 2020, and the rates should have been quoted by contractor seeing the situation of COVID-19, the rates have been quoted by himself @ Rs. 55,300/- (Rs. 54086/- monthly installment & Rs. 1214/- income tax) which is not the fault of this office. The PCB asked about the views & suggestion of the Board members in this matter.

# **OFFICE REPORT**

It is submitted that PDDE Central Command Lucknow vide letter no. 57973/e-samiksha/Cantt/43 dated 23-11-2020 has directed this office for installation of roof top solar panels on Cantt Board Buildings and vacant land for energy usage on self-sustaining basis and energy efficient street lighting system in Ranikhet Cantonment area.

It is also to inform the board that earlier the matter regarding installation of roof top solar power system was placed before the board and the board vide its CBR NO. 04 dated 01-08-2017 resolved that roof top solar panel is not a feasible plan for Ranikhet Cantonment.

The Cantonment Board has conducted a survey with PEC, Limited (a Govt. of India Enterprise, New Delhi) regarding installation of rooftop solar panel in Cantt Area in compliance with instruction received from higher authorities. As per recommendations of the PEC Ltd. 64 kwp renewal energy solar PV power plant can be installed in Cantt Area.

As per report of technical section dated 01-02-2021, the roof top solar panel is a feasible plan for Ranikhet Cantt, if proper shedding/safety are provided to solar panels.

Hence matter is placed before the board for consideration and approval for the installation of roof top solar system and vacant land in Ranikhet Cantonment area.

# **RESOLUTION**

21. Considered and approved. The board resolved that the financial condition of Cantonment Board is not good. Hence, the approach be made to State Govt. authorities for providing funds for installation of roof top solar panels. Further board resolved that after availability of funds, roof top solar panel be installed with proper shedding/safety provided to solar panels at office of the Cantonment Board, Cantt Primary School, Cantt Guest House, Cantt Inter College and at observatory bungalow and other locations. In this regard final report be put up before board along with estimates.

Further it is submitted that the pumping of water from Devi Dhunga is also decreasing due to which the general public is facing difficulty and complaints are regularity received to the office in this regard. The supply of water has also been reduced from daily to 4 days in a week. Keeping in view the shortage of water due to summer season and incidents of forest fire, it will be difficult to supply the adequate water through our pipelines.

In this regard, this office approached to Executive Engineer, Uttarakhand Jal Sansthan, Ranikeht, Almora. In response the Executive Engineer, Uttarakhand Jal Sansthan, Almora vide letter No. 628 / মুবা বাহন / 05, dated 16-03-2021 stated that the present new rate not been sanctioned by DM, Almora and the last year sanctioned rate is been provided i.e. water supply through 3000 ltr water tanker @ Rs. 4950/- per day per and Rs. 36.40 fuel per km. these rates are approved by the District Magistrate, Almora. The Cantonment Board has its own 5 KL water tank along with pipes, but it requires truck for allotment of water through 5 kl water tank and Rs. 1000/- may be reduced by Cantonment Board since pipes are available in Cantonment Board.

In this regard this office invited tender for hiring/providing the truck (load capacity 5000 kl water tank) vide this office letter No. 133 / निविदा सूचना / 21, dated 04-03 2021 and advertisement published in news paper Danik Jagran and Hindustan. Three valid bids received by this office within stipulated period, among which the lowest rates have been quoted by M/S Satish Kumar Singh, Ranikhet.

It is submitted that as per report of Work supervisor, Cantt. Board, Ranikhet the working of 60 HP pumps and motor at Devi Dhunga pump house is giving low discharge of water at Stock Yard water tank. In this regard a letter has been sent to Executive Officer, Uttarkhand Jal Sansathan, Ranikhet for inspection of 60 HP pump and Motor at Devi Dhunga pump house. In this connection as joint inspection was conducted on dated 26-07-2020. Further, in this connection a letter has been received by this office from the Executive Officer of Uttarkhand Jal Sansathan, Ranikhet vide letter no. 1031/Vi. Kha. Tarikhet/21, dated 30-07-2021 stating that the pumps and motor are running 20-22 hours per day and they have became older as they are running from 5 to 6 yrs. In this connection motors and pumps need to be replace so that the proper supply of water can be provided to the general public of Ranikhet. In this regard for supply and installation of 60 HP pump-motor set, e-tender were invited vide ID No. 2020 DGDE 581078 1, dated 02-09-2020 through the advertisement published in news paper Danik Jagran and Hindustan, only 02 bids received by this office in the stipulated period. The tender was not completed, again e-tender was invited vide ID No. 2020 DGDE 583689 1, dated 14-09-2020 and again 02 bids received by this office in the stipulated period and the same process held. Third time e-tender was invited vide ID No. 2021 DGDE 614241 1, dated 04-02-2021 through the advertisement published in news paper Danik Jagran and Hindustan, but this time no bid received by this office. Forth time etender was invited vide ID No. 2021 DGDE 620530 1, dated 04-03-2021 through the advertisement published in news paper Danik Jagran and Hindustan for the supply and installation of 60 HP pumps (02nos) at Devi Dhunga pump house. In this tender two bids were received by this office within stipulated period, one bid cancelled in technical bid as he is not able to supply and install the pump within time period as per terms and condition of tender. Only one bid was found valid by this office of M/s Jai Sai Engineering, Almora.

After opening of tender, it is found that out of 22 valid bidders total 14 bidders have quoted the L1 rate i.e. 0.01% service charge for outsourcing of manpower. In this connection, as per above condition of tender notice, this office has compared the work experience and number of outsourced employees in govt. departments of above 14 bidders/firms. Wherein, it is found that the work experience, number of outsourced employees of M/s Trio Security and Intelligence Private Limited, New Delhi is higher than other 13 bidders.

The highest rates (i.e. 62% of total tickets) have been quoted by Shri Himanshu Pandey, Himalaya Tour Out Door Adventure, Laxmeshwar Almora. He has submitted his experience certificate of 6 years and also submitted the documents of two trainers.

It is pertinent to mention here that keeping in view the security of tourist in adventure park, the agency and their trainers should be experience holder. The tourists may get injured during adventurous acitivities in absence of experienced trainers.

Hence the matter is placed before the board for consideration.
